AGREEMENT

Agreement made this ____ day of March, 2023 between the Town of Greenwich, New York, a Municipality, with office at 2 Academy Street, Greenwich, NY 12834 (hereinafter the "Town") and Shannon Celeste-Hahn with office at 20 River Road, NY 12834 (hereinafter "Celeste-Hahn").

WHEREAS, the Town is in need of Dog Control on a regular basis; and

WHEREAS, Celeste-Hahn is in business of providing dog control services;

NOW THEREFORE, it is hereby agreed by and between the parties as follows:

1. Celeste-Hahn agrees to provide dog control services to the Town.
2. The Town agrees to pay Celeste-Hahn the sum of \$1,000.00 per quarter, as well as \$20 per dog picked up and mileage for said pick-ups at the rate set by the Town Board at the annual Organizational Meeting held in January and \$30.00 per summons as for service of process. Such payment(s) to be made upon the submission of a voucher to the Town prior to each Town Board meeting, such voucher to cover services rendered for the prior month.
3. Prior to commencing work, Celeste-Hahn shall provide the Town with Proof of Liability and Workers Compensation insurance as applicable.
4. This Agreement shall cover the period commencing April 1, 2023 and ending December 31, 2023.
5. This Agreement may be terminated by either party with a 30 day written notice.

AGREEMENT

THIS AGREEMENT, made this ___ day of March, 2023 between the **TOWN OF GREENWICH**, Washington County, New York, [hereinafter designated as the Town Board], and **ST. JOSEPH'S CATHOLIC CHURCH**, Washington County, New York, [hereinafter designation as the Church],

WITNESSETH:

WHEREAS, the Town Board of the Town of Greenwich, has passed a Resolution authorizing the making of a contract with the Church to lease space for the summer program for school children, and

WHEREAS, The Board of Directors of the Church, has authorized their entering into such contract with the Town of Greenwich;

NOW, the aforesaid parties do hereby enter into a contract to lease space from the Church for the summer program for school children, this contract for leased space by and between the Town Board of the Town of Greenwich, County of Washington, a municipal corporation of the State of New York (hereafter Town Board), and the Church, the owner of premises in the Village and Town of Greenwich, Washington County, (hereinafter Church) represents the full and complete agreement between the parties hereto and hereby binds the executing parties to the following terms:

TERMS

1. The term of this contract is that of one year period commencing on 1st day of January, 2023 through 31st day of December, 2023 and shall be renewed on an annual basis in an amount as mutually agreed between the parties.

2. The Town Board agrees to pay as consideration for the lease of space agreed to be provided herein by the Church, the amount of \$1,500.00 as and for full payment for a lease for one year. Said payment is to be tendered to the Church after the execution of this contract and no later than June 1, 2023.

3. The lease payment shall be the only payment for the leased space, with the Church paying all other expenses, such as heat and electricity, etc.
